Before the Board of Supervisors this evening is proposed Resolution No. 8 – 2023. This resolution would authorize the submission of a grant application to the Chester County Municipal Grant Program for a park and trail improvement grant for improvements to West Goshen Community Park. Specific components would include the improvements to the basketball court, the installation of a splash pad, drainage improvements at the tennis courts, and the expansion of the bathroom facilities. As West Goshen Community Park is approximately 32 acres, the Township would be eligible for funding at a maximum of 50% of the cost up to \$250,000. Applications are due by February 28, 2023.
