RESOLUTION NO. 11 – 2023

A RESOLUTION OF WEST GOSHEN TOWNSHIP, CHESTER COUNTY, PENNSYLVANIA AUTHORIZING THE SUBMISSION OF A GRANT APPLICATION TO CHESTER COUNTY VISION PARTNERSHIP PROGRAM FOR THE DEVELOPMENT OF A PARK, RECREATION, AND OPEN SPACE PLAN.

WHEREAS, the Commissioners of Chester County have established the Vision Partnership Program to be utilized by the municipalities of Chester County; and

WHEREAS, the grants may be used by the municipality for the development Park, Recreation, and Open Space plans; and

WHEREAS, the municipality of West Goshen Township, Chester County, Pennsylvania desires to participate in the Vision Partnership Program.

NOW, THEREFORE, BE IT RESOLVED by the governing body of West Goshen Township, Chester County, Pennsylvania, as follows:

1. That the municipality of West Goshen Township, Chester County, Pennsylvania hereby approves the filing of an application for Chester County Vision Partnership Program for assistance.

2. West Goshen Township commits to forming a project task to guide the completion of the plan in accordance section 8.2.B.5. of the Chester County Vision Partnership Cash Grant Manual.

3. West Goshen Township has allocated \$75,000 in its 2023 budget in the Capital Reserve Fund toward the cost of this project. West Goshen Township commits to funding a 50% match toward the cost of the project.

4. That Christopher Bashore, Township Manager, is hereby authorized to execute and file the appropriate forms with the Chester County Planning Commission.
