Before the Board of Supervisors this evening is proposed Ordinance No. 8-2023. This ordinance would amend chapter 78 (Vehicles & Traffic) of the West Goshen Township Code of Ordinances. Specifically, the proposed ordinance would amend sections 78-9, 78-12, and 78-21 of Chapter 78 of the Township's Code of Ordinances. By way of background information, Dave Woodward, Public Works Director, identified a number of stop intersections that were not properly codified and updated those accordingly. In addition, certain stop intersections are proposed to be removed and the direction of travel in certain areas would be revised. Finally, the proposed ordinance would add three (3) areas where parking would be prohibited at all times.

The proposed ordinance was discussed at the May 2, 2023 meeting of the Board and authorized for advertisement. The proposed ordinance was advertised in the May 10, 2023 edition of the Daily Local News as required. Additionally, the proposed ordinance was posted on the Township website in the "Ordinances & Resolutions" section.

**ORDINANCE NO.   8   - 2023**

**AN ORDINANCE OF THE TOWNSHIP OF WEST GOSHEN, CHESTER COUNTY, PENNSYLVANIA, AMENDING CHAPTER 78 OF THE WEST GOSHEN TOWNSHIP CODE, TITLED “VEHICLES AND TRAFFIC”, TO AMEND SECTION 78-9 TITLED, “STOP INTERSECTIONS” TO ESTABLISH NEW STOP INTERSECTIONS AND REMOVE CERTAIN EXISTING STOP INTERSECTIONS; SECTION 78-12, TITLED, “SPEED LIMITS” TO ADD SPEED-LIMIT ZONES; AND TO AMEND SECTION 78-21 TITLED, “PARKING PROHIBITED AT CERTAIN TIMES” TO ADD PARKING RESTRICTIONS AT CERTAIN LOCATIONS.**

**BE IT ENACTED AND ORDAINED**, by the Board of Supervisors of West Goshen Township, that the Code of the Township of West Goshen, specifically Chapter 78, titled, “Vehicles and Traffic”, shall be amended as follows:

**SECTION 1.** Section 78-9, titled, “Stop intersections” shall be amended as follows:

a. The following stop intersections are added:

**SECTION 2.** Section 78-12, titled, "Speed limits" shall be amended to add the following speed-limit zone:

**SECTION 3.** Section 78-21, titled, "Parking prohibited at certain times" shall be amended by adding the following parking restrictions:

Name of Street	Side	Location	Restriction
Trott Lane	Both	From beginning of cul-de-sac to the end of the cul-de-sac	No Parking anytime
Gallop Lane	Both	From beginning of cul-de-sac to the end of the cul-de-sac	No Parking anytime
Fallen Timbers Lane	North	From South Five Points Road to cul-de-sac	No Parking anytime

**SECTION 4. SEVERABILITY.** If any provision, sentence, clause, section or part of this ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts hereof. It is hereby declared as the intent of the Board of Supervisors that this Ordinance would have been adopted had such

unconstitutional, illegal or invalid provision, sentence, clause, section or part thereof not been included herein.

**SECTION 5. EFFECTIVE DATE.** This Ordinance shall become effective five days after enactment.

**SECTION 6. REPEALER.** All ordinances or parts of Ordinances conflicting with any provisions of this Ordinance are hereby repealed insofar as the same affects this Ordinance.
