

NOTICE IS GIVEN that the Board of Supervisors of West Goshen Township will conduct a public hearing on **Tuesday, October 20, 2020** as part of the regularly scheduled public meeting which begins at 7:00 p.m., prevailing time at the West Goshen Township Building, 1025 Paoli Pike, West Chester, Pennsylvania 19380, to consider and possibly adopt an Ordinance. The Ordinance amends the West Goshen Township Code of Ordinances with the following title and summary:

**AN ORDINANCE OF THE TOWNSHIP OF WEST GOSHEN,
CHESTER COUNTY, PENNSYLVANIA, AMENDING CHAPTER 78
OF THE WEST GOSHEN TOWNSHIP CODE, ENTITLED
“VEHICLES AND TRAFFIC”, SPECIFICALLY SECTION 78-20 TO
PROHIBIT PARKING ON THE SOUTH SIDE OF WARREN ROAD
FROM ELTON CIRCLE TO SCHOOLHOUSE LANE.**

ORDINANCE NO. 4- 2020

AN ORDINANCE OF THE TOWNSHIP OF WEST GOSHEN, CHESTER COUNTY, PENNSYLVANIA, AMENDING CHAPTER 78 OF THE WEST GOSHEN TOWNSHIP CODE, ENTITLED "VEHICLES AND TRAFFIC", SPECIFICALLY SECTION 78-20 TO PROHIBIT PARKING ON THE SOUTH SIDE OF WARREN ROAD FROM ELTON CIRCLE TO SCHOOLHOUSE LANE.

BE IT ENACTED AND ORDAINED, by the Board of Supervisors of West Goshen Township, that the Code of the Township of West Goshen, specifically Chapter 78, titled, "Vehicles and Traffic", shall be amended as follows:

SECTION 1. Section 78-20, titled, "Parking prohibited at all times" shall be amended to add the following parking prohibition:

<u>Name of Street</u>	<u>Side</u>	<u>Location</u>
Warren Road	South	From Elton Circle to Schoolhouse Lane

SECTION 2. SEVERABILITY. If any provision, sentence, clause, section or part of this ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts hereof. It is hereby declared as the intent of the Board of Supervisors that this Ordinance would have been adopted had such unconstitutional, illegal or invalid provision, sentence, clause, section or part thereof not been included herein.

SECTION 3. EFFECTIVE DATE. This Ordinance shall become effective five days after enactment.

SECTION 4. REPEALER. All ordinances or parts of Ordinances conflicting with any provisions of this Ordinance are hereby repealed insofar as the same affects this Ordinance.
